

3.Technical specifications

Input: DC 12.0-24.0V Output:

USB-C1/USB-C2/USB-A:5V=3A

4.Operation

(1)Plug the car charger into car socket.

(2) When using the built-in retractable cable of the car charger to charge the device(s):

Directly pull out the retractable cable and connect the port USB-C1/USB-C2 of the retractable cable to the USB-C charging port of the device being charged.

(3)When using the other two ports USB-A/USB-C of the car charger to charge the device(s):

Connect one end of charging cable to car charger's charging port. Connect the other end of the charging cable to the charging port of the device being charged.

(4)The display area will be shown out the input voltage.

5.Cautions:

(1)To prevent fire or electric shock, keep away from liquids and moisture.

(2)Do not operate this adaptor with a damaged plug.

(3)This adaptor is not intended for use by children. Adult supervision is always required when children are present. In case of emergency, discontinue use immediately. For example:
