



## 2C+2A CHARGING STATION User Manual

### Features

Support Max 35W fast charging



### Safety Notes

1. Do not disassemble or throw into fire or water, to avoid damage.
2. Do not use charging station in severely hot, humid or corrosive environments, to avoid circuit damage and occur leakage phenomenon.
3. To take care of the children, to ensure that they won't play the charging station as a toy
4. In emergency cases, unplug the charging station when smoke from the unit, changed shape, liquid or material leakage.
5. Do not use charging station when it is damaged or broken parts.
6. This charging station is intended for indoor use only.
7. For use with AV/IT equipment.
8. The socket-outlet shall be installed near the equipment and shall be easily accessible.

1. Plug & Go: Just connect and start. Voltage and power will automatically configured by device with fast charging function.
2. For efficient and optimize charging, the fast charging function must be supported by your terminal device.
3. The fast charging function may be affected when both output ports are used in the same time.
