

Support USB-C Power Delivery 3.0 (45W max) and Quick Charge 3.0 (18W max) fast charging devices (Laptops, iPad, iPhone, iPod, Samsung and other Android smart phones, tablets).



### Safety Notes

1. Plug the AC power cord (included) and connect. LED indicator light will turn blue when power connected. Voltage and power will automatically configured by PD/QC 3.0.
2. For efficient and optimize charging, the PD/QC 3.0 function must be supported by your terminal device while qualified rapid charging cable is needed.
3. Charging six devices simultaneously in standard charge.  
\*Note: Charging speed may affected if the USB cable not supporting PD or QC 3.0 fast charging function. Use a supported USB Power Delivery cable to enjoy fast charging.
